Learner Home is the easiest place to access all your TAL Risk Academy courses and content. Here's a quick overview of how it works




Launch Learner Home

Get started by logging in to the TAL Risk Academy at riskacademy.tal.com.au.

Then, launch the Learner Home dashboard by either:
